Only Bids from Bidders who pass the eligibility check will be opened. The Schedule of Prices must be submitted with the Original Copy of the Invitation to Apply for Eligibility and to Bid together with the Photocopy of the Business Permit. The bidder with the Lowest Calculated Bid shall advance to the technical and financial requirements of the project.
